### **RESOLUTION 2018-09-33**

**WHEREAS**, the City of Scottsboro has an average household income below that of the state and national averages and;

**WHEREAS**, the city of Scottsboro has a need for quality affordable entry-level housing, and;

**WHEREAS**, the members of the City Council believe that a review of the City's rules and regulations is in order to insure that the city does not unintentionally inhibit the market for entry level housing;

**THEREFORE BE IT RESOLVED** by the City Council of the City of Scottsboro as follows, the City Council of Scottsboro requests the Scottsboro Planning Commission's input and recommendations on reducing subdivision and other regulatory requirements to minimum levels that provide for public safety and quality while allowing for growth and development of entry level housing.

**BE IT FURTHER RESOLVED** that the council requests this matter be considered at the Commission's October meeting.
